 - Report aggregated as one fund
- Negative entries restricted
- New Codes
 - Code 633 – Due to Financial Institution for Overdrawn Accounts
 - Code 90168 – Fire Retirement expenditures

Financial Statements

Bulk Load

- Allows import of account code entries
 - Import file must be in correct format
- Two options for bulk load:
 - Replace all financials
 - Merge file with financials
- Bulk load not available for supplemental schedules

 - Current vs advanced refunding
- Interest expense

Supplemental Schedules

Bond Repayment Schedule (New)

- Summarizes annual bond debt service
- Linked to Statement of Indebtedness (SOI)
 - SOI needs to be marked complete first
 - Principal payments should match SOI records



How to Prepare

- Resolve current accounting/reporting issues.
- Prepare to collect new data elements.
 - Bond Repayment Schedule.
 - Statement of Indebtedness changes.
 - Police and Fire Retirement expenditures separated.
- Review Summary of Changes
