Note [1]: The NYSOH program is managed using a combination of full time staff and staff drawn from shared service pools, such as infrastructure support. Totals in this category include all staff who charged 20 hours or more to the program during the reporting period.

Note [2]: The NYSoH contract is primarily a fixed price services contract, with an hourly component for changes to the computer applications ("Supplemental"). The directions for this form require the use of specified employment categories, which in many cases do not directly correspond to the job descriptions used on the NYSoH program. We have, however, mapped the NYSoH categories as closely as possible to the specified categories, with the result that the categories contain a combination of fixed price and Supplemental staffing. For the category of Supplemental, which is the only component where compensation to GDIT is related to the hours worked, GDIT provides detailed monthly time reporting, by individual, and by Supplemental project, to NYS DOH as part of the monthly billing for those services. For the fixed price element, staff work the number of hours necessary to complete assigned tasks, and GDIT's compensation under the program is based on a monthly fixed charge, and not upon hours worked.

Note [3]: NYSoH, as a fixed price services contract, provides full integration of all elements

necessary to manage the NYSoH program, including hardware, software, technology licenses and maintenance, telecommunications, facilities, and staffing. The amounts payable for these services are not calculated using staffing as a basis, therefore there is no ability to report "Amount Payable Under the Contract".
