

**THRESHOLDS FOR OSC CONTRACT APPROVAL AND PROCUREMENT ADVERTISING**

The following charts summarize thresholds for the Office of the State Comptroller (OSC) contract approval requirements, and procurement advertising (New York State Contract Reporter) for State agencies, State University Construction Fund (SUCF) and City University Construction Fund (CUCF). Different requirements apply to public authorities (other than SUCF and CUCF), localities and other government entities.
